3. The representative of the respondents states that the complete information has already been supplied to the appellant in this case with which the appellant was satisfied except a copy of complaints/submissions of the 3rd party was not supplied. 3. The appellant sought the action taken on the complaint dated 15.10.2020 sent to the Health Minister, Punjab. A reference has already been received from the Director, Health & Family Welfare, Punjab vide which the Civil Surgeon, Ludhiana was directed to supply the status of the complaint to the appellant. The representative of the respondents on behalf of the Civil Surgeon, Ludhiana states that the reply has also been sent to the appellant with a copy to the Commission, which is reproduced below:-
