3. Sh. Santokh Singh, Superintendent appears on behalf of the Respondents and orally submits that information sought by the Appellant has already been provided to him in the Appeal Case Nos. 2192/2019 and 2199/2019. He further requests to club the all three cases on the same date i.e. 26.09.2019.
