- 4. Today the RTI of the Appellant has been discussed between both the parties. Accordingly, regarding point no.1, the Respondent is directed to provide the list of persons promoted. Further, regarding point no 3 the Respondent is directed to provide the result of the Appellant. Regarding point no.4 the copy of rules and regulations of DPC is to be provided to the Appellant.
