ORDER :

1. This order may be read with the reference of previous order of the Commission dated 22.08.2022 vide which respondent representative ASI Ramesh Kumar assured the Commission to provide the requisite information before the next date of hearing, **but he failed to do so.**
2. At the time of hearing the back ground noise from the respondent side was distracting/disturbing the court proceedings. Despite of giving various warning to respondent ASI Tarsem Singh to stop the background noise but he was failed to do so. For this, a strict warning is issued to the O/o DC Ludhiana to be very careful while representing the case in future, failing to which penalty of Rs 5000/- will be imposed on the concerned PIO.
Further in addition, the Commission instructs the Respondent Public Authority to convene periodic conferences/seminars to sensitize, familiarize the concerned officials about the attend virtual hearing through Cisco Webex, to keep the court proceedings focused and also educate about the relevant provisions of the RTI Act, 2005 for effective discharge of its duties and responsibilities.
3. The respondent authority moreover is cautioned to exercise due care in future to ensure that correct and complete information is furnished timely to the RTI applicant(s) as per provisions of the Act failing which penal proceedings under Section 20 shall be initiated.
