ORDER

1. The RTI application is dated 22.06.2020 vide which the appellant has sought information as enumerated in his RTI application. First appeal was filed with the First Appellate Authority (hereinafter FAA) on 26.06.2020 and second appeal was filed in the Commission on 08.07.2020 under Section 19 of the Right to Information Act, 2005 (hereinafter RTI Act).

2. Notice of hearing was issued to the parties for 12.10.2020.

3. Appellant, Sh. Jagshir Singh states that requisite information has been received from the respondent PIO and requested to close this case.

4. Respondent, Constable, Maninder Singh is present for today's hearing.

5. After hearing the appellant and examining the case file, it is observed that appellant demanded the following information in RTI application dated 22.06.2020:-

- 3) ਦੇਰੀ ਨਾਲ ਅਦਾਲਤ ਪੇਸ਼ ਕੀਤੇ ਗਏ ਚਲਾਨ ਦੇ ਵੇਰਵੇ ਦੀ ਤਸਦੀਕ ਸ਼ੁਦਾ ਕਾਪੀ।
- 4) ਦਰਜ ਮੁਕੱਦਮਿਆਂ ਦੀ ਮੌਜੂਦਾ ਸਥਿਤੀ ਅਤੇ ਦੋਸ਼ੀਆਂ ਨੂੰ ਮਿਲੀਆਂ ਸਜ਼ਾਵਾਂ ਦੇ ਵੇਰਵੇ ਦੀ ਤਸਦੀਕ ਸ਼ੁਦਾ ਕਾਪੀ।
- 5) ਉੱਕਤ ਮੁਕੱਦਮਿਆਂ ਵਿੱਚ ਬਰੀ ਹੋਏ ਦੋਸ਼ੀਆਂ ਦੇ ਵੇਰਵੇ ਦੀ ਤਸਦੀਕ ਸ਼ੁਦਾ ਕਾਪੀ।
- 6) ਮੰਗੀ ਸੂਚਨਾ ਜੇਕਰ ਹੋਰ ਦਫਤਰ ਨਾਲ ਸਬੰਧਤ ਹੈ ਤਾਂ ਆਰ.ਟੀ.ਆਈ. ਐਕਟ ਦੀ ਧਾਰਾ 6(3) ਅਧੀਨ ਤਬਦੀਲ ਕੀਤੀ ਜਾਵੇ।
