2. The Appellant states that the information sought has not been provided to him.
3. The PIO is absent. The PIO has not provided requisite information to the Appellant. The Appellant has also highlighted that till date complete information has not been provided to him. It clearly shows that there is **a delay of about 2 months** for not supplying the information to the Appellant, which is definitely on a higher side and cannot be given a go by. Besides, the deemed PIO O/o Station House Officer (S.H.O.) Dakha Police Station, District Ludhiana seems totally unmindful and indifferent to the orders issued by the Commission on a number of occasions and he has openly defied the same, before reaching to the conclusion, it is relevant to reproduce the last order of the Commission: -

2. *The Appellant is absent and the PIO is also absent for today's hearing, inspite of the Notice/Orders of the Commission. This shows his disregard to the Commission. As the absence of PIO has affected the proceedings of hearing as also disposal of the case, the absence of the PIO is viewed seriously.*

3. *The PIO is directed to bring along the original record relating to the RTI application dated 11.08.2022 of the appellant and produce before the Bench and file his written submission in response to the Notice of the Commission and should present this case personally in the Commission, on the next date of hearing. In case information sought by the appellant is not available in the official records, then PIO is directed to file an **Affidavit/Undertaking** in this regard and produce the same before the Bench, on the next date of hearing, failing which action will be initiated against him as per provisions of the RTI Act, 2005.*

4. *The matter is adjourned to 12.10.2022 at 11:30 AM in the Commission. Both the parties are directed to present their case personally.*

4 Thus, the Commission draws the inference that the PIO, without any reasonable cause, has malafidly delayed information and thus, has rendered himself liable for punishment as provided under the RTI Act, 2005. He was given a number of opportunities to provide the information to the Appellant but he is delaying the matter on one pretext or the other. In these circumstances, **Shri Daljit Singh, Inspector, Deemed PIO – cum – Station House Officer (S.H.O.) O/o Dakha Police Station, District Ludhiana** is held guilty of default on the above score.

5. The facts of this case also proved beyond any doubt that the respondent PIO concerned does not deserve any kind of leniency. Hence, in exercise of the powers conferred by Section 20(1) of the RTI Act, 2005, **a penalty to the tune of Rs. 10,000/- (Rupees Ten thousand only)** is imposed upon Shri Daljit Singh, Inspector, Deemed PIO – cum – Station House Officer (S.H.O.) O/o Dakha Police Station, District Ludhiana to be deducted from his salary, which is to be deposited in the State Treasury under the relevant head.

6. The Drawing and Disbursing Officer O/o Inspector General of Police, Ludhiana Range, Purani Kacheri, Ludhiana is directed to deduct the amount of penalty of Rs. 10000/- from the salary of Shri Daljit Singh, Inspector, Deemed PIO – cum – Station House Officer (S.H.O.) O/o Dakha Police Station, District Ludhiana and deposited in the State Treasury in the following Head of Account and to report its compliance to the Commission: -

- 86-Fee under the RTI Act, 2005
