

- 4. The appellant, Sh. Ramandeep Singh Ahluwalia , who appeared in person in today's hearing, orally states that he has received the required information and the case be closed.
- 5. Since complete information has been supplied by the respondent PIO and the appellant has also given his consent to close the case, hence, the instant appeal-case is announced as **disposed of and closed**.
