1. The complainant, Raghubir Singh, filed this RTI application dated **29.6.2020** and sought information **CCTV Cameras installed in Thana Sadar, Moga**, from the PIO o/o Moga. When no information was received, the Complainant filed a complaint under Section 18 of the RTI Act, 2005 to the Commission on **14.8.2020**. The case was last heard on **24.9.2020**.
2. Both the parties are present through Video Conference in the DC office at Moga. The respondent PIO, represented by SI Balwinder Singh, additional SHO Police Station Sadar and ASI Surinderpal Singh of the RTI branch, office of SSP Moga, as directed at the last hearing, have submitted a copy of the reply sent to the Complainant on 9.9.2020. In this, exemption from disclosure is sought under Section 8(1)(h) of the RTI Act. As per their contention, the matter is pertaining to the RTI application is under investigation.
3. The respondent now states that the investigation is over and has been filed in the Court. However, pertaining to the request for CCTV footage in the RTI application, the respondent states that all the CCTV Cameras footage is automatically deleted after 18 days and therefore, not available any more. The Complainant contested this stating that he had specifically requested the SSP Moga to preserve the CCTV footage cited in his RTI application.
4. Under the circumstances, this Commission directs the respondent PIO-cum-SSP, Moga, to submit a duly Notarized Affidavit responding to each of the 5 points in this RTI application. The affidavit must also clearly give the status of the CCTV footage including the contention made at today's hearing that all CCTV footage gets automatically deleted after 18 days. This is to be submitted within the next 15 days. The original Affidavit is to be handed over to the Complainant either by hand or by Registered Post. A copy of the same is to be emailed to this Commission along with the Complainant's receiving/copy of postal receipts and dispatch register.
