1. The complainant, **Harjeet Singh Dhillon**, filed this RTI application dated **31.8.2020** and sought information **regarding a site plan – No. 107B, Permit No. 19310 of 14.10.2016 – in the names of Gurpreet Singh and Bhupinder Singh, both sons of Himmat Singh, in five points**, from the PIO o/o **M.C., Zone-B, Ludhiana**. When no information was received, the Complainant filed a complaint under Section 18 of the RTI Act, 2005 to the Commission on **15.12.2020**. This complaint case was last heard on **18.3.2021**.

2. Both parties are present via Video Conference from Ludhiana. The respondent PIO, submitted a reply dated 8.7.2021 bearing No. 1283/ATP-B/RTI/D, stating that the information has already been given to the complainant earlier in response to Appeal Case No. 66 and 67 of 2019, which came up for the hearing before Hon'ble State Information Commissioner, Sh. Sanjeev Garg. The appellant is however, not satisfied and has stated that the respondent has still not replied to specific queries in his RTI application.

3. This Commission concurs with the complainant and directs the respondent PIO to file a written pointwise reply to the specific queries and documents sought by the complainant including point 1, which cites the report submitted by the building inspector after physical inspection of the property cited in this RTI application. This must be done within 10 days of receiving this order.

1. The complainant, **Harjeet Singh Dhillon**, filed this RTI application dated **31.8.2020** and sought information **regarding his application to the Zonal Commissioner on 1.6.2020**, from the PIO o/o **M.C., Zone-B, Ludhiana**. When no information was received, the Complainant filed a complaint under Section 18 of the RTI Act, 2005 to the Commission on **15.12.2020**. This complaint case was last heard on **18.3.2021**.

2. Both parties are present via Video Conference from Ludhiana. The respondent PIO has not produced any document or Court Order to show that the information requested by the appellant has been proscribed from disclosure or publication.

1.
