2. The appellant is absent. However, an e-mail dated 12-02-2019 is received in the Commission office from the appellant. He has stated that the respondents have supplied incomplete information. He has pointed out certain deficiencies in the provided information.

3. A photocopy of the letter pointing out deficiencies by the appellant in the provided information is handed over to the representative of respondents in the court. The respondents are directed to supply the information as per deficiencies pointed out by the appellant.
