2. Respondent, Sh. Sukhbir Singh states that requisite information cannot be supplied to the appellant as per the Section 8 of the RTI Act and reply has already been sent to the appellant. He added that concerned school i.e. G.B. International School is an Un-Aided school and not receiving any grant from the Government, therefore this school does not fall under the ambit of RTI Act. He further added that RTI application could not be transferred to the school under Section 6(3) because this school is not a Public Authority under Section 2(h) of the RTI Act.

He submits a reply dated 13.11.2019 signed by Sh. Kulbhushan Singh Bajwa, DEO (SE), Patiala stating that appellant moved an application dated 24.05.2019 to seek information on various points like Service Book, EPF No. House Rent and Payment of Leave Encashment and reply was sent to the appellant dated 20.06.2019 stating that sought for information cannot be provided because this is a private school.

3. Appellant, Ms. Rajpreet Kaur expresses her dissatisfaction with the supplied reply and demanded the requisite information.

4. After hearing both the parties and examining the case file, it is observed that RTI application of the appellant was addressed to the respondent PIO, Office of DEO (SE), Patiala and office of DEO (SE), Patiala falls under the ambit of RTI Act, 2005

It is also observed as stated respondents this School (G.B. International School) not receiving any aid/grant from the State/Central Government and purely private school so it does not fall under the purview of the RTI Act. It is also observed School is affiliated to Central Board of Secondary Education (CBSE) and the control of CBSE is with Central Government.

5. In wake of above, no cause of action is left. Therefore, the instant appeal case is **disposed of & closed.**
