**ORDER**

1. The Hon'ble Chief Information Commissioner, Sh. S.S.Channy vide Office Order dated 05.02.2019 has allocated the above mentioned case to decide the complaint dated 31.08.2015 of Sh. Jagmohan Singh Makkar against Sub Registrar, Ludhiana (West) in the present case i.e. Appeal Case No. 1648 of 2015 by Division Bench consisting of Ld. SIC, Dr. Pawan Kumar Singla and Ld. SIC, Sh. Sanjiv Garg. Accordingly the case was fixed for hearing today.

2. Applicant, Sh. Jagmohan Singh Makkar is not present for today's hearing but an email dated 08.02.2019 has been received by the Bench of Undersigned stating that he is unable to attend today's hearing and requested for an adjournment in this case. This mail is taken on record.

3. Respondent PIO is also not present for today's hearing but an email dated 12.02.2019 has been received by the Bench of Undersigned stating that he is unable to attend today's hearing and requested for an adjournment in this case. This mail is taken on record.

4. After examining the case file, it is observed that as per order dated 31.01.2019 passed by the Hon'ble High Court in CWP No. 10571 of 2018, the decision on this complaint is to be taken within a period of 60 days but both the parties are not present for today's hearing. Both the parties are advised to represent this case in person on the next date of hearing so that case could be decided as per the directions of the Hon'ble High Court.

5. Appellant, Sh. Jagmohan Singh Makkar is advised to represent this case in person on the next date of hearing to clear the facts of this case, failing to which case will be decided in his absence. He is also advised to bring the following documents on the next date of hearing positively:

- Copy of the information supplied by respondent PIO O/o Sub Registrar, Ludhiana (West) in AC No. 1648 of 2015
- Copy of self declaration handed over by Sh. Arvinder Pal Singh during the hearing on 20.3.2013 of AC No. 206 of 2013.
- Comparative statement of the information supplied in the both the above cases (AC: 206 of 2013 and AC: 1648 of 2015) identifying the deficiency in the provided information.

6. Respondent PIO is directed to appear in person to represent this case positively. A copy of this order along with copy of complaint of the appellant dated 31.08.2015 be sent to him by name through **registered post** for his ready reference.
7. Matter is adjourned for further hearing on **20.03.2019 at 11:30 A.M.**
