The RTI application is dated 6.3.2020 vide which the appellant has sought information as enumerated in his RTI application. First appeal was filed with the First Appellate Authority (hereinafter called FAA) on 10.9.2020 and second appeal was filed in the Commission on 14.10.2020 under Section 19 of the Right to Information Act, 2005 (hereinafter called RTI Act). Notice of hearing was issued to the parties for today.

2. The appellant has sought the following information:-

2) ਸੂਚਨਾ ਦਿੱਤੀ ਜਾਵੇ ਕਿ ਪ੍ਰਾਪਤ ਹੋਈਆਂ ਤਜਵੀਜ਼ਾਂ ਦੇ ਆਧਾਰ ਤੇ ਕਿਸ ਮਿਤੀ /ਮਿਤੀਆਂ ਨੂੰ ਸਰਕਾਰ ਵੱਲੋਂ ਪ੍ਰਭਾਵਿਤ ਕਿਸਾਨਾਂ ਨੂੰ ਬਣਦਾ ਮੁਆਵਜ਼ਾ ਦੇਣ ਹਿਤ ਲੋੜੀਂਦੀ ਰਕਮਾਂ ਜਾਰੀ ਕੀਤੀਆਂ ਗਈਆਂ ਹਨ।”

3. The appellant states that the respondents are not providing the information as he has sought the information regarding dates pertaining to the funds released for giving compensation to the affected farmers etc. But the respondents are demanding the fee amounting to Rs.600/-. However, the representative of the respondents contended that the information is not maintained as has been sought by the appellant. He further states that the information has not been denied as the complete file relating the sought information is being provided to the appellant but he is not depositing the requisite fee pertaining to the information.

4. After deliberations, the appellant states that the sought dates of only Jalandhar district may be provided with which the respondent-Public Information Officer agreed to supply the same today through email/whatsapp.

5. After the hearing is over, the respondent-Public Information Officer sent a copy of the letter bearing No. 191 dated 13.1.2021 and the relevant portion of the letter is reproduced below:-

6. After going through the same the appellant shows his satisfaction over the provided information. He also states that he has no objection in case his case is closed.

7. According to the submissions made by the appellant, the Commission observes that the sought information has been supplied to the appellant as per the deliberations and satisfaction of the appellant, therefore, no further action is required to be taken in this case. Hence, the case is disposed of and closed. A copy of the letter dated 13.1.2021 is **sent** with this order to the appellant.
