It is very strange and intriguing that despite the express directions followed by a show cause notice to the PIO, O/o Department of Local Government (LG - 1 Br.), he has maintained a stony silence. The Commission is inclined to believe that Sh. Harjit Singh, PIO – cum – Superintendent is malafidely and willfully withholding the information and defying the order of the Commission. A final opportunity is afforded to him to comply with the directions passed by the Commission. Be it noted that he is already under the show cause notice of imposition of penalty.

However, in view of his submission, his request is accepted with direction to ensure the supply information by the aforesaid time, failing which the penal provision shall be invoked."

The case has come up today for hearing. Sh. Swaran Singh, Panchayat Secretary appearing on behalf of the respondents submits that the asked for information has been provided. The appellant points out a deficiency with reference to a bank statement maintained by the department. The Panchayat Secretary assures the Commission that he will make good the deficiency. The Commission feels, by and large, that the information sought has been provided. The bank statement should also be furnished to him immediately. With the consent of both the parties the appeal is **disposed**.
