The case was first heard **on 31.10.2018.**The respondent present pleaded that since this case relates with GLADA, he is appearing on behalf of the PIO. The respondent sought an adjournment and assured to provide the information to the appellant before the next date of hearing.

The case was adjourned. The PIO was directed to relook at the RTI application and provide the information to the appellant as per RTI application and be present on the next date of hearing.

The case was last heard on 11.12.2018. The order is reproduced hereunder:

"The respondent present pleaded that the information is voluminous and cannot be provided and the appellant was asked vide letter dated 28.05.2018 to specify the name of the school for which the appellant wants the information since consolidated information regarding schools running in the villages falling in all Tehsils of Ludhiana District is not available with them. The respondent has also cited instructions vide letter No.437-39 dated 17.02.2008 of the Department of Information Technology (Administrative Reforms) which reads as under:

"Only such information is required to be supplied under the Act which already exists and is held by the public authority or held under the control of the public authority. The CPIo is not supposed to create information or to interpret information or to solve the problems raised by the applicants or to furnish replies to hypothetical questions"

The respondent further informed that there are around 927 villages and their field staff was asked to provide the information but the field staff has informed that the information regarding private schools is not available with them.

I have gone through the RTI application and found that the information sought is very voluminous and will involve diversion of resources.

Appeal Case No. 2737 of 2018

The Supreme Court in a case; Central Board of Secondary Education &Anr.v. Aditya Bandopadhyay& Anr observed that, "the nation cannot afford to have the honest public officials bogged down with all and sundry request unrelated to corruption as it will adversely affect the efficiency of the government agencies. The Act should not be allowed to be misused or abused, to become a tool to obstruct the national development and integration, or to destroy the peace, tranquility and harmony among its citizens. Nor should it be converted into a tool of oppression or intimidation of honest officials striving to do their duty. The nation does not want a scenario where 75% of the staff of public authorities spends 75% of their time in collecting and furnishing information to applicants instead of discharging their regular duties. The threat of penalties under the RTI Act and the pressure of the authorities under the RTI Act should not lead to employees of a public authorities prioritizing 'information furnishing', at the cost of their normal and regular duties.

Since the appellant is not here to plead his case, the case is adjourned. The PIO is directed to provide information regarding point 1 only till the next date of hearing."

Hearing dated 13.02.2019:

The respondent present pleaded that in compliance with the order of the Commission, a complete list of all schools under the jurisdiction of the Ludhiana has been provided to the appellant. The appellant is absent and vide email has sought exemption.

I have gone through the information and found that the information has been provided by the PIO to the best possible extent.

No further course of action is required. The case is disposed off and closed.

Order:

The case was first heard on **14.11.2018**. The respondent present submitted a letter dated 10.08.2018 vide which the appellant was asked to specify the information. The respondent pleaded that since the information is voluminous and the appellant has not specified the information he wants.

It was observed that the respondent has not replied to the RTI application well in time and First Appellant Authority has also not taken any decision on the appeal of the appellant dated 11.06.2018. The PIO was directed to relook at the RTI application and provide the point-wise information to the appellant. The PIO was also directed to be present personally on the next date of hearing and explain the reasons for delay in attending to the RTI application.

The case was last heard on **08.01.2019**. The appellant stated that a specific list was sent to the PIO as per order of the Commission but yet the information has not been provided. The PIO was directed to provide the information to the appellant within 15 days and send compliance report to the Commission.

Hearing dated 13.02.2019:

The respondent present pleaded that they have record of only six colonies and has brought the record. The respondent further pleaded that the appellant be asked to inspect the record and get whatever the information he wants.

The appellant is directed to inspect the record. The PIO to provide the information of six colonies free of cost and send a compliance report to the Commission.

No further course of action is required. The case is disposed off and closed.
