4. After telephonic conversation with Sh. Paramjit Singh, Builing Inspector cum APIO O/o MTP, MC, Amritsar (98039-52100) states that his reporting officer and in this instant case **Sh. Sanjeev Devgan ATP, MC, Amritsar (98883-20785) is the concerned respondent PIO** and it is again telephonically confirmed with Sh. Anil Arora, Superintendent cum PIO O/o Commissioner, MC, Amritsar (98886-92001).
5. After hearing the appellant and examining the documents placed on record, due to continues absence of the PIO despite of due notice(s) and directions under RTI Act, the concerned PIO O/o Commissioner, MC, Amritsar i.e. **Sh. Sanjeev Devgan ATP, MC, Amritsar has** not complied with the orders of the undersigned, therefore in exercise of powers vested in the Commission under section 18(3) of RTI Act read with relevant provisions of Civil Procedure Code, **I here by direct that Bailable Warrant be issued for appearance of Sh.
