In the view of above, that the appellant has wasted the time of Public Authority and the Commission and also bulk and indefinite information is requisite by him therefore, the appellant is advised that he may file fresh RTI application to the PIO's of individual districts and/or departments with specifying proper time period for which information is required and hence, no further action is required in this case and hence this instant appeal case is **disposed of and closed.**
