1. This order may be read with the previous order dated 08.03.2022 vide which respondent, Sh. Dheeraj Kumar stated that reply has already been sent to the appellant on 28.06.2021. Complainant intimated that respondent PIO was directed by the Commission after discussion on 18.11.2021 regarding supplied reply dated 28.06.2021 but after that he has not even supplied a single page after the directions of the Commission.

It was observed by the undersigned Bench that ample time has elapsed but respondent's causal approach towards his duties as a Public Servant is uncalled for. A final opportunity was awarded to him to supply the complete requisite information to the appellant on his visit to the respondent's office on 15.03.2022, failing which action as per RTI Act will be initiated against the concerned respondent PIO. A copy of previous order was sent to the respondent PIO and Sh. Dheeraj (BI) who presented case on the previous hearing by name through registered post for their ready reference. Matter was adjourned for further hearing on 13.04.2022 i.e. today.

2. In today's hearing, representative of the complainant, Sh. Avnish Khosla states that he had visited the respondent's office on fixed date i.e. 15.03.2022 but demanded information was not supplied to him. He requests the Commission for directions to the respondent PIO to supply an affidavit in this case duly attested by the oath Commissioner.
3. Respondent, Sh. Parminder Singh is present for today's hearing.
4. Request of the appellant is granted; respondent PIO is directed to supply an affidavit in original duly attested by the oath Commissioner as per queries raised in RTI application immediately with a copy to the Commission.
5. Both the parties are advised to represent this case in person on the next date of hearing, failing to which, appropriate order in their absence shall be passed.
6. The matter is adjourned for further hearing on **18.05.2022 at 11:00 A.M. through CISCO WEBEX application**. Copy of the order be sent to the parties.
