**ORDER**

1. The above mentioned was last heard by the Hon'ble Chief Information Commissioner, Sh. S. S. Channy dated 26.03.2019 and this case file was sent to the Registry to re-allocate this case to other bench.

6. Hence, I award an interim compensation of Rs. 1,500/- (Fifteen Hundred Only) to the appellant. The compensation amount must be paid by the respondent PIO concerned through cheque or demand draft in favor of **Rachna Sharma** from the account of Public Authority and not from the individual's account.

7. Respondent PIO is directed to produce a copy of the cheque or demand draft on the next date of hearing.

8. Respondent PIO is directed to supply the requisite information to the appellant by or on the next date of hearing. He is also directed to appear in person along with Sh. Lalit Sharma before the Commission to represent this case, failing to which action as per RTI Act will be initiated against him. A copy of this order be sent to him through registered post. A copy of this order be sent to the respondent PIO, O/o Tehsildar, Ludhiana (West) by name through **registered post** for his ready reference.

4.
