

On the asking of the Bench, he states that the enquiry which was marked to the SSP Vigilance, Bathinda on 14.07.2018 for verification of the facts, has been got conducted by SSP Vigilance, Bathinda through Shri Sandeep Singh, DSP, Vigilance Bureau Unit, Sri Muktsar Sahib who has submitted his report. He further states that the said enquiry report is to be got approved from the Chief Director, Vigilance Bureau, Punjab. The enquiry report is then shown to the Bench.
