Order

The RTI application is dated 25.8.2021 vide which the appellant has sought information as enumerated in his RTI application. First appeal was filed with the First Appellate Authority (hereinafter called FAA) on 04.10.2021 and second appeal was filed in the Commission on 10.12.2021 under Section 19 of the Right to Information Act, 2005 (hereinafter called RTI Act). Notice of hearing was issued to the parties for today.

2. The appellant has sought the following information pertaining to Shri Manmohan Kaushik, Tehsildar posted at Jagroan.
