3 The appellant has been informed accordingly on telephone and he has requested the Commission to direct the respondent Public Information Officer to provide the remaining information pertaining to point no. 2 and 4 of the RTI application.

4. According to the assurance given by the respondent-Public Information Officer, she is directed to supply the remaining information pertaining to Point No. 2 and 4 of the RTI application within two weeks from the issue of this order. With these directions, the case is disposed of and closed. However, the liberty is granted to the appellant to approach the Commission within four weeks if he does not receive the information pertaining to Point No. 2 and 4 of the RTI application. A copy of the information so received from the respondent-Public Information Officer is being **sent** to the appellant along with this order.

The RTI application is dated 9.9.2021 vide which the appellant has sought information as enumerated in his RTI application. First appeal was filed with the First Appellate Authority (hereinafter called FAA) on 8.11.2021 and second appeal was filed in the Commission on 13.12.2021 under Section 19 of the Right to Information Act, 2005 (hereinafter called RTI Act). Notice of hearing was issued to the parties for today.

2. The appellant has sought the following information:-

3. The respondent further states that complete information as available on record has already been sent to the appellant on 3.1.2022. He further states that the C.R. Number is not available in the office as the office is not a party in the said case filed in the Hon'ble Punjab and Haryana High Court, Chandigarh, as has been claimed by the appellant.
