4. I have carefully perused the documents on record. Before proceeding/parting with the order, I would wish to place on record that the First Appellate Authority did not take any action on the appeal of the Applicant. He neither summoned the parties nor did he pass any order, which shows that the FAA has not acted as per the mandate of the RTI Act, 2005. This inaction on the part of the FAA needs to be depreciated and it is hoped that the authorities entrusted with judiciary duties under the Act show more sense of responsibility and respect for the rights of the citizens.

5. In view of the aforesaid, the instant matter is remanded to the FAA. The Commission hereby directs the FAA to decide the matter in accordance with the provisions of the RTI Act after giving all concerned parties an opportunity to be heard.
