APPEAL CASE No. 1920 OF 2020

When no information has been received from the PIO, he has filed First Appeal with the First Appellate Authority (hereinafter FAA) on 14.02.2020 but no reply has been received from him and he has filed Second Appeal in the Commission on 21.07.2020 under Section 19 of the Right to Information Act, 2005 (hereinafter RTI Act) and as such Notice of hearing was issued to the parties for 13.10.2020.

The matter is taken up today. The Appellant states that no information has been provided to him by the Respondents.

After examining the case file, it is observed that information sought by the Appellant is in shape of questions, therefore, information cannot be provided to him. Moreover the Respondent is not public entity and not covered under the Section 2 (f) of the RTI Act, 2005.

Central Information Commission vide order dated 21.04.2006 in case no. CIC/AT/A/2006/00045 has decided that -

(The RTI Act does not cast on the public authority any obligation to answer queries, as in this case, in which a petitioner attempts to elicit answers to his questions with prefixes, such as, why, what, when and whether. The petitioner's right extends only to seeking information as defined in Section 2 (f) either by pinpointing the file, document, paper or record, etc., or by mentioning the type of information as may be available with the specified public authority.)

In wake of above the instant Appeal Case is hereby **disposed of and closed.**
