withdraw the show cause notice issued to him. He has also submitted the written submissions in this regard, which is taken on record.

3. After consideration of the submissions made by the respondent-Public Information Officer Sh. Dilbag Singh, the show cause notice issued to him is here by withdrawn. It is also a fact that the representative of the respondents travelled around 300 km and brought along with the original record pertaining to the sought information but the appellant is absent. Also the representative of the appellant Shri Ramandeep Singh Ahluwalia came before the hearing and informed the office that he is appearing on behalf of the appellant and the office informed the representative of the appellant that the respondent party is also present along with the original record. But as soon as the hearing starts, the representative of the appellant.

4.
