

"The appellant is seeking information about the particulars of the officials who have not filed their property returns with the public authority concerned. The respondent, represented by Shri Navjot Singh, ETO states that the information has been sent to the appellant vide communication dated 25.06.2019. Nothing is on record to ratify the same. The Commission finds that the response is very belated after a lapse of about 8 months. The respondents are directed to file a written reply to the notice of the Commission and explain the delay. Meanwhile, they should endorse a copy of the reply sent to the appellant, to the Commission also for its perusal.

The case has come up today. The Commission has perused the reply sent by the

Since the appellant and the respondents are same and the information sought and emanates from the same incident, the single order shall dispose off all the appeals.

Notice was issued to the respondents on the request of the appellant to treat it as a case of life and liberty under proviso to section 7(1) of the RTI Act as he was a victim of an assault and the FIR under Section 307 and other sections of IPC stand registered on 23.05.2019 in the jurisdictional police station. The appellant is absent, as the notices for

hearing were sent only a couple of days before, seemingly it has not been delivered to him. The respondents nonetheless are present. He should approach the office of the concerned magistrate to seek the information relating to investigation and the charge sheet. They further say that the original incident occurred in May, 2019. The exemptions under section 8 (1) (h) of the RTI Act are not afforded to them. They are directed to allow the appellant the inspection of the record
