ORDER:

The appellant through an RTI application dated 05.04.2018 has sought information on 10 points regarding details of patients referred by the Civil Hospital, Pathankot to Guru Nanak Medical College, Amritsar from 31.03.2012 to 28.02.2015 and 31.03.2015 to 31.03.2018 – the details of drivers of ambulances along with the logbooks for the last 6 years – appointment letters of new drivers of the ambulances – total funds allocated to the Civil Hospital Pathankot – Syrup, Corex received by the Pathankot hospital –contracts entered for the canteen, cycle stand and other information as enumerated in the RTI application concerning the office of Civil Hospital Pathankot. The appellant, not satisfied with the information provided by the PIO, filed the first appeal before the First Appellate Authority on 06.12.2019, which took no decision on the appeal. After filing the first appeal, the PIO did send some information to the appellant vide letter dated 06.01.2020.

The case last came up for hearing on 09.08.2021 through video conferencing at DAC Pathankot. The respondent was absent.

The Commission received a letter from the PIO on 20.04.2021 stating that they have already sent the information to the appellant vide letter dated 16.04.2018, 25.02.2019 and 06.01.2021 and a copy of the CD containing all relevant information was sent to the Commission. The PIO further mentioned in the letter that a representative of the appellant also visited their office and inspected the record and gave a statement that they are satisfied with the provided information.

As per the appellant, the information provided by the PIO was incomplete.

Since the appellant was in disagreement with what had been provided, PIO was directed to provide an affidavit, in which it is stated that, whatever the information has been provided is true, complete and no further information is available relating to this RTI application.

Appeal Case No. 3724 of 2020

Hearing dated 13.12.2021:

The case has come up for hearing today through video conferencing at DAC Pathankot. The respondent has sent an affidavit as per the order of the Commission which has been taken on the file of the Commission. The appellant is present through WhatsApp and informed that she has not received the affidavit.

A photocopy of the affidavit is being retained and the original affidavit is being sent to the appellant along with the order.

With the above, the information stands provided. No further interference is required.

ORDER:

The appellant through an RTI application dated 27.08.2020 has sought information regarding the amount of grant provided per person for the treatment of Covid-19 positive case by Punjab Govt, Central Gov. and WHO and other information as enumerated in the RTI application concerning the office of Directorate of Health and Family Welfare, Pb Chandigarh. The appellant was not satisfied with the information provided by the PIO provided the information after which the appellant filed the first appeal before the First Appellate Authority on 27.10.2020 which took no decision on the appeal.

The case last came up for hearing on 09.08.2021 through video conferencing at DAC Patiala/Mohali. The respondent present pleaded that they received the RTI application on 02.12.2020 through the Directorate of Health Services & Family Welfare and the reply was sent to the appellant vide letter dated 15.01.2021.

The Commission received a copy of the letter from the PIO-National Health Mission, Punjab on 09.06.2021 vide which the PIO had sent a reply to the appellant that no grant was provided per person for the treatment of a Covid-19 positive case by NHM.

The appellant was not satisfied with the information provided and pleaded that he has sought information from the Directorate of Health & Family Welfare regarding the grant received/provided by Punjab Govt., Central Govt and WHO.

The PIO-National Health Mission was exempted.

The case was sent back to the Directorate of Health Services & Family Welfare, Pb with the direction to file an appropriate reply if any 'per person' grant was issued by the Punjab Govt., the Central Govt or WHO.

Hearing dated 13.12.2021:

The case has come up for hearing today through video conferencing at DAC Patiala/Mohali. The respondent present informed that in compliance with the order of the Commission, a reply has been sent to the appellant vide letter dated 22.10.2021 with a copy to the Commission.

The appellant has received the same.

Since the information has been provided, no further course of action is required. The case is **disposed of and closed**.

ORDER:

The appellant through an RTI application dated 11.06.2020 has sought information regarding the copy of the register of death and birth relating to VPO Banbhaura, PS Amargr from the year 1950 to 31.12.1970 and other information as enumerated in the RTI application concerning the office of Civil Surgeon-cum-,Registrar, Birth & Deaths, Sangrur. . The appellant was not provided with the information after which the appellant filed first appeal before the First Appellate Authority on 02.09.2020 which took no decision on the appeal.

The case last came up for hearing on 09.08.2021 through video conferencing at DAC Patiala/Sangrur. The respondent present pleaded that the information that has been sought by the appellant is not readily available and has to be created and the reply has been sent to the appellant vide letter dated 12.02.2021.

The appellant was absent. The case was adjourned.

Hearing dated 13.12.2021:

The case has come up for hearing today through video conferencing at DAC Sangrur. The respondent reiterated his earlier plea that the information is not readily available and has to be created since there is no specific record being maintained for an individual village and the record is being maintained collectively for all villages of the District.

I am in agreement with the contention of the PIO and of the view that if the appellant is still interested in obtaining the information, the appellant should either specify the information that the appellant is seeking or inspect the record at a mutually convenient time.

The appellant is absent on 2nd consecutive hearing nor is represented.

Appeal Case No. 3732 of 2020

Hereby, if the appellant still wants information, he is allowed to inspect the record by fixing a suitable convenient date & time with the PIO and get the relevant information by depositing the requisite fee as per RTI Act.

The PIO is directed to allow inspection of the record and provide relevant information to the appellant.
