

4. Keeping in view the above, the Commission is of the view that no further action is required to be taken in this case. Hence, the case is disposed of and closed.

ORDER

The RTI application is dated 23.9.2021 vide which the appellant has sought information as enumerated in his RTI application. First appeal was filed with the First Appellate Authority (hereinafter called FAA) on 23.10.2021 and second appeal was filed in the Commission on 21.1.2022 under Section 19 of the Right to Information Act, 2005 (hereinafter called RTI Act). 3. After detailed deliberations with both the parties regarding the sought information viz a viz information supplied, the respondent-Public Information Officer is further directed to supply the rate of annual increment of all the staff members list of which has already been supplied to the appellant. He is further directed that in case the rate of annual increment remains the same, then the specific reply be provided to the appellant within two weeks. With these directions, the case is disposed of and closed. However, the liberty is granted to the appellant to approach the Commission within four weeks, if she does not receive the same.
