2. Both parties are present. The appellant is present in person. As per respondent PIO, represented by Jasdeep Singh, SDO, the appellant was informed vide Letter No. 1189 Dated 29.3.2022, that the information requested is voluminous based on which he was invited to inspect the record in the PIO's office and obtain copies after payment of requisite copying cost. The appellant wrote back to the PIO on 9.4.2022, that he was ready to pay the copying cost and once again requested that the information be sent to him by post.

3. Following this, the respondent PIO, while making no reference to the appellant's request, once again invited him to the office for inspection. It is notable here that the First Appellate Authority convened 2 hearings on 17.5.2022 and 22.6.2022, which the appellant did not attend, but he duly informed the FAA that the information be supplied to him by post on payment of copying costs. The FAA in its Order No. 87185 Dated 24.6.2022, directed the respondent PIO to supply the information requested by the appellant as per the RTI Act 2005. Subsequent to that, the respondent PIO did not take any other action, thereby compelling the appellant to file this Second Appeal.

4. The Commission notes that while the respondent PIO did reply to the RTI application within the prescribed period of 30 days and sent at least one reminder thereafter, he failed to apprise the appellant of any detail regarding the copying costs and merely held back the requested information on the premise that the information is voluminous.

5. The Commission Orders as follows:-

i] The respondent PIO is hereby directed to make a precise assessment of copying cost involved in supplying the information requested by the appellant in his RTI application submitted on 19.3.2022, which must be intimated to the appellant with a copy to this Commission.

ii] The appellant, who has already been subjected considerable harassment for no fault of his own, has agreed to pay 50% of the copying cost intimated by the respondent. The remainder of the information is to be provided to the appellant free of cost.

iii] All copies are to be attested as "Information provided under the RTI Act 2005", and accompanied by a covering letter, signed by the respondent PIO-cum-XEN, Punjab Mandi Board, Civil Division, Patiala.

6. This must be done within 30 days of receipt of this Order. This Appeal is accordingly **Disposed of**.


