**ORDER**

5. On not receiving any response from the Respondent within 30 days as mandated under Section 7(1) of the RTI Act 2005, the appellant filed first appeal with the First Appellate Authority vide application dated: 06.07.2017 under the provisions of Section 19(1) of the RTI Act, 2005 and subsequently approached the Commission in Second Appeal under Section 19(3) of the RTI Act 2005, which was received in the Commission on 16.01.2018 and accordingly, a notice of hearing was issued to the parties.

6. In view of the above, the Respondent – PIO (Sh. Jaspreet Singh Kahlon, DFSC, Sangrur) make use of the next date of hearing for his personal hearing as well under the principles of natural justice and explain his conduct and status of the case and enable the Commission to arrive at a reasonable / logical conclusion in the matter.

7. The appellant is advised to follow up his case in the Commission, failing which decision shall be taken on merit.
