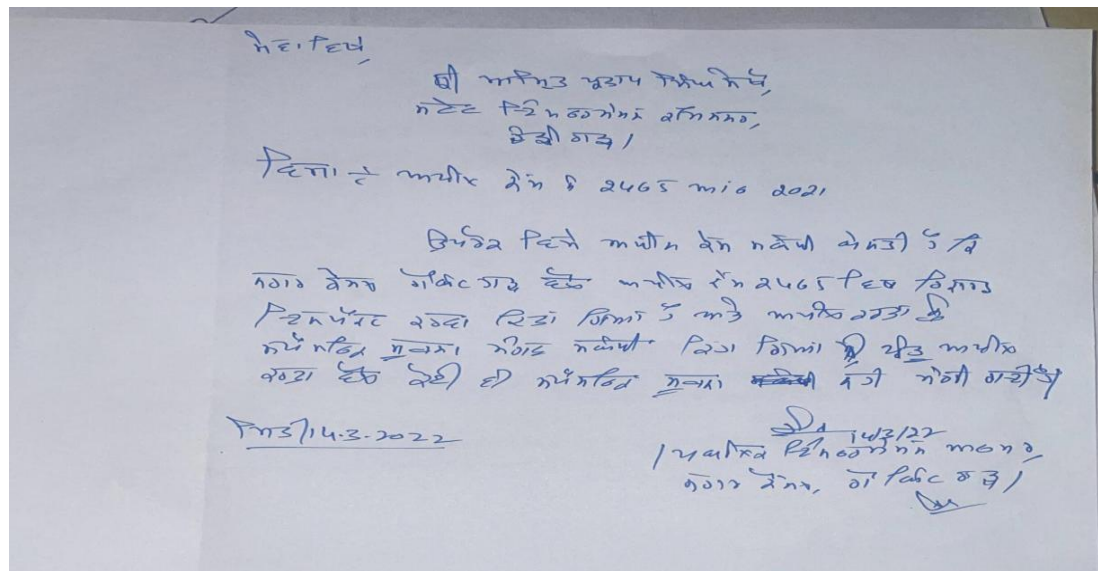
This order may be read with reference to the previous order dated 17.12.2021 vide which the appellant was absent.

**ORDER**

The RTI application is dated 11.10.2021 vide which the appellant has sought information as enumerated in his RTI application. First appeal was filed with the First Appellate Authority (hereinafter FAA) and second appeal was filed in the Commission on 15.11.2021 under Section 19 of the Right to Information Act, 2005 (hereinafter RTI Act).

2. Notice of hearing was issued to the parties for 14.03.2022 i.e. today.
3. The Appellant states that the information provided to him is not complete and he is not satisfied with the same.
4. The Respondent states that the information, as available in their official record, has been provided to the appellant. Further, they have also filed an affidavit stating as under:-

2. That the appellant Sh. Jai Chand s/o Sh. Jaimal Ram was contractual employee of the respondent (PESCO), who was deployed at Punjab State Power Corporation Limited (PSPCL in short), Out Let Store, Fazilika wef 01 Mar 2018 on outsourcing basis as per contract agreement with PSPCL (Principal Employer) and appellant was transferred to Guru Gobind Singh Super Thermal Plant (GGSSTP), Ropar on 26.07.2019 as per terms & conditions of appointment letter and on the recommendation of the Senior Executive Engineer, Central Store, Ferozepur.

3. That the appellant has filed the present appeal i.e. Appeal Case No 5166 of 2021 before the Hon'ble Court and date of hearing was 14.03.2022. Respondent (PESCO) has been forwarded reply dated 02.03.2022 along with connected documents related to Appeal No 5166 of 2021 to Punjab State Information Commission, Sector 16, Chandigarh with a copy to the appellant.

4. It had been clarified by PIO, PESCO that all the relevant information/documents held with office of Punjab Ex-servicemen Corporation have already been provided to the appellant and nothing is concealed by the respondent (PESCO) .

5. It was also clarified that PESCO is a service provider and the principal employer being PSPCL, with whom PESCO has an agreement for services being provided. PSPCL does not come under purview of PESCO and the latter, therefore, cannot institute an inquiry against PSPCL employees.

6. That the deponent states that the information supplied to the appellant Sh. Jai Chand as per the office record is correct and nothing has been concealed therein.

Copy of the same is taken on record.

5. After hearing both the parties and perusing the case file, it is ascertained that the information lying with PIO O/o Respondent has been provided to the Appellant. Further, the PIO states that the original record/information is lying with PSPCL and PESCO being a service provider has an agreement for services being provided and PSPCL does not come under the purview of PESCO. The Respondent has also filed their rely via Commission diary no. 4837 dated 08.03.2022 stating that cases in similar matters have been listed before Hon'ble State Information Commissioners Punjab, Lt. Gen Ajae Kumar Sharma and Sh. Asit Jolly and they have been disposed off and closed on the same grounds. They have also filed a copy of the orders of the same.

**ORDER**

This order may be read with reference to the previous order dated 05.02.2022 vide which appellant was directed to visit the office of the respondent on 10.01.2022 and inspect the record.

2. Today the appellant states that he had inspected the record but he is not satisfied with the same. He further states that he has received the information pertaining to point no. 1 only.

It is further ascertained that the respondent has also sent point-wise reply to the Commission as well as to the appellant.
