2. The case has been heard today in Commission's office at Chandigarh. The appellant Shri Sarabjeet Singh Gill is absent for today's hearing. Shri Amarjit Singh Dhamotia comes present to attend the hearing on behalf of the appellant.
3. Neither the PIO O/o Municipal Corporation, Ludhiana has come present in person nor through cisco webex nor directions of the Bench regarding filing of affidavit as also producing the evidence for having deposited the amount of penalty have been complied with.
4. The PIO is again directed to comply with the directions of the Bench in totality as also ensure to come present in person before the Bench on the next hearing. The appellant is also advised to come present in person before the Bench on the next hearing.
5. With the aforesaid directions, the matter is adjourned. **To come up for hearing on 21.06.2022 at 11.30 AM before the Bench in Commission's office at Chandigarh.** Copies of the order be sent to the concerned parties.
