- vii) In case part of the information sought by the applicant pertains to some other PIO, the application be transferred to him U/s 6(3) of RTI Act, 2005.
- viii) Kindly provide an appointment to verify the original records pertaining to information sought after providing the information

The Commission has heard the appellant. SI Jarnail Singh, APIO is present. It transpires from the discussion that the appellant apprehends threat to his life as he was assaulted by some miscreants and suffered severe injuries and had remained hospitalized for 17 days. He submits that he has taken it upon himself to expose a land Mafia operating in the area. The Mafia is out to eliminate him.

The respondents admit that an FIR no.90 dated 01.06.2019has been registered at Police Station, Dakha. The assailants have been identified and Police claims to apprehend them soon. The Commission having considered the aforesaid facts, believes that he is entitled to the information in 48 hours. The respondents have failed to provide him the information despite

seriousness of the issue.

The Commission directs the respondent-PIO to provide him the information within 48 hours from today positively. they shall take immediate steps to assess the threat perception to appellant and take immediate appropriate action under intimation to the Commission."

The respondents have submitted a copy of a letter dated 04.08.2019 which suggests that the appellant has been supplied with the information asked for. The Commission has also perused a notification dated 11.01.2013 issued by the department of Home Affairs and Justice on the subject of providing security to the Whistle Blowers/RTI activists. Clause 3(a) of the notification reads as under:

"The Whistle Blowers/RTI activists/Complainants/Witnesses in cases who have a threat perception of danger to his/her life or liberty may approach the District Magistrate or the Commissioner of Police as the case may be. The concerned authority shall make an Enquiry into the threat perception within 48 hours of the receipt of the application and if it is found that the threat perception is genuine, he/she shall be provided security forthwith."

As intimated by the DSP, Dakha, the Deputy Commissioner Ludhiana, who heads the committee, has been requested to assess the threat perception to the appellant so that the follow up action can be taken accordingly. The respondents are advised to act according to the dictate of aforesaid notification, since the appellant claims to be an RTI Activist and it is incumbent upon the

respondents to ensure the safety of the citizens."

The case has again come up today. SI Jarnail Singh, who is representing the respondents, states that due to some pressing reasons the committee could not meet to assess the threat perception to the appellant. He states that the matter is under their active consideration. They propose to take the action expeditiously. The Commission observes that the information sought has been provided to the appellant.

It is incumbent upon the respondents to take requisite action as envisaged under policy referred to above. The Commission hopes that they will do it without further delay. The Commission underlines that the respondents takes appropriate action expeditiously, in view of the fact that the appellant has been assaulted and inflicted injuries upon and an FIR stands registered. With these observations matter is **disposed**.

<u>ORDER</u>

The case has been heard through video conferencing.

The Commission had made following observations on 03.10.2018:

"The appellant vide his application dated 10.01.2018 had asked for an information

relating to various activities of the gram panchayat during its tenure from 2013 to 2018. An appeal was filed with the First Appellate Authority in March, 2018 as well. Having failed to procure the information the appellant has been constrained to file the second appeal with the Commission.

Sh. Gursahib Singh, Panchayat Secretary appearing on behalf of the respondents submits that the then jurisdictional Panchayat Secretary had proceeded on ex. India Leave without giving the charge to anybody. That he has been entrusted with the charge in the last 7 – 8 days and assures to provide the information expeditiously.

The BDPO, Faridkot should have given the charge to someone in the absence of Panchayat Secretary. The appellant was to be furnished with the information in the stipulated time.

Having failed to do so, he has rendered himself liable for penal consequences.

Sh. Ashok Kumar who reportedly is holding the charge of the post of Block Development & Panchayat Officer, Faridkot and is PIO in the instant case is issued a show cause notice to explain in a self- attested affidavit as to why a penalty @ Rs.250/- per day of delay subject to maximum of Rs.25,000/- till the complete information is furnished, be not imposed under Section 20(1) of RTI Act, 2005 on him for causing willful delay / denial of the information to the RTI applicant and why the compensation be not awarded to the Appellant under Section 19 (8) (b) of the Act for the detriment suffered by him.

In addition to the written reply, the PIO is also given an opportunity under Section 20(1) proviso thereto, for a personal hearing before the imposition of such penalty on the next date of hearing. He may take note that in case he does not file his written reply and does not avail himself of the opportunity of personal hearing on the date fixed, it will be presumed that he has nothing to say and the Commission shall proceed to take further proceedings against him ex parte."

The matter has come up today. Sh. Gursahib Singh, Panchayat Secretary, submits that he has been able to lay hand to the record only today, which informally has already been shown to the appellant. The Commissions directs the respondents to have it duly inspected by the appellant and provide him the certified copies of the documents, which

should be relevant to the information seeker, but not beyond one hundred pages. He should also ensure that the documents related to the muster roll as mentioned in his application shall also be arranged to be provided immediately.
