ORDER

1. This order may be read with the reference of previous order dated 17.07.2019.
2. Sh. Jasbir Singh, the appellant states that documentation fee of Rs 6768/- for 3384 pages has already been provided (and re-examining the record, it is found to be true) but still information that relates with point no. 2 & 3 is still pending.
3. Sh. Charanjit Singh, states that partial pending information relates with Ms. Divya Goswami, FSO, Sh. Ravinder Garg Assistant Commissioner (Food) and may be impleaded as necessary party in this case.
4. After hearing both the parties and going through the documents placed on record, I am of the view that due to evasive attitude and irresponsible behavior of the respondent PIO concerned, the appellant has suffered a lot of detriments for not getting the requisite information and/or not getting it in time, therefore, I am of the view that compensation be awarded to the appellant, **Sh. Jasbir Singh**.
5. Hence, I award an interim compensation of Rs. 1500/- (Fifteen Hundred only) to the appellant. The compensation amount must be paid by the respondent PIO concerned through cheque or demand draft in favor of **Jasbir Singh** from the account of Public Authority and not from the individual's account and provide it to the appellant. The respondent must submit a copy of said cheque or DD, to the Commission and also intimate the Commission in this regard and once it has been paid to the appellant.

ORDER

1. This order may be read with the reference of previous order dated 17.07.2019.
2. Sh. Jasbir Singh, the appellant states that requisite information is still pending and nor did the respondent has given him the compensation awarded.
3. Respondent PIO is absent for today's hearing without any intimation to the Commission. He/she was also absent on previous hearing dated 28.05.2019 before the bench of undersigned and also on hearings dated 17.10.2018, 18.12.2018 & 05.02.2019 before the bench of LD. 5. In the backdrop of the aforementioned factual position, initiation of action under Section 20(1) Right to Information Act, 2005, against the concerned defaulting officer called for, imposition of penalty upon **the concerned PIO O/o Food Safety, Moga, of Rs. 10,000/- (Ten Thousand only).**

Thereafter, Dr. Jitender Virk, (80546-06139) is acting as FSO, Moga from February 2019 till date.
7. In the view of this **Sh. Abhinav Kumar, presently FSO, Barnala & Dr. Jitender Virk, FSO, Moga** are directed to represent this case on next date of hearing. Also, they are directed to provide requisite information to the appellant by the next date of hearing and also follow the instructions regarding compensation awarded and penalty imposed as directed in order on previous hearing dated 17.07.2019; failing to which action under section 20 (1) would be enhanced against the concerned respondent official .
8. A telephonic message in this regard has also conveyed to Sh. Abhinav Kumar, presently FSO, Barnala (98882-23720) and Dr. Jitender Virk, (80546-06139) FSO, Moga by the bench of undersigned.
9. Dr. Arwinder Gill, FAA cum Civil Surgeon, Moga also failed to disclose the Name and other details of concerned defaulting officer (PIO) to the Commission and representing this case in person or through his/her representative on today's hearing.

The Civil Surgeon, Moga is also directed to ensure that this amount of penalty is deducted from the salary of the above said concerned defaulting official (s) and deposited in the Treasury under the relevant head and issue instructions to his official(s) to present the Challan and/or relevant evidence(s) before the Commission on next date of hearing positively. The Civil Surgeon Moga is also directed to represent this case in person or through his/her representative on next date of hearing.

After hearing respondent and going through the documents placed on record, the respondent PIO Cum Superintendent (Revenue) O/o DC, Jalandhar and respondent PIO Cum DDPO, Jalandhar both will **Show Cause** under Section 20 (1) of the RTI Act, as to why penalty be not imposed upon them for willful delay/denial in supplying the information to the RTI appellant and why the compensation be not awarded to the information-seeker under the provisions of the RTI Act, 2005.

In addition to their submissions, the PIO(s) are also hereby given an opportunity under Section 20(1) provision, thereto, for a personal hearing before the imposition of such penalty and/or compensation be awarded to the appellant on them on the next date of hearing.
