2. Sh. J M Singh- representative for the Appellant states that the complete information has not been provided till date. Copy of the same is taken on record.

4. Sh Rupinder Singh Sadhrao, PIO appearing on behalf of respondent no.2 states that the information has already been provided to the appellant.
5. After hearing both the parties and examining the case file, it is observed that the complete information has not been provided to the Appellant till date. Respondent no. 1 states that a part of information is lying ready with them. Further, it is also ascertained that the Respondent no.1 has again failed to file their reply to the show-cause notice. Hence Respondent no.1 is given a last opportunity to file their reply to the show-cause notice and to provide complete information to the Appellant before the next date of hearing failing which punitive provision of the RTI Act, 2005 could be invoked. Further, Respondent no.2 is directed to provide complete information to the Appellant, after the removal of deficiencies, as pointed out by the Appellant.
