ORDER

1. 2. In today's hearing, respondent, Sh. Davinder Chauhan states that information in connection with point no. 1 and 8 has already been supplied to the appellant and rest of the information relates with more than 2 PIOs. He also mentioned that appellant was asked to deposit the documentation fee amounting Rs. 1,000/- against the pending information but not deposited by the appellant till date.
3. On this representative of the appellant, Sh. Sanjeev Goyal states that an estimated fee was demanded by the respondent, so it was not deposited.
