ORDER

Shri Qaseem Haider, appellant filed RTI application dated 04.08.2020 and sought some information from the SPIO, O/o Senior Superintendent of Police, Mohali.

Today the case is heard through CISCO Webex Meetings Software.

The appellant is absent today, whereas the respondent is present.

The respondent stated that the appellant was contacted through phone on 23.07.2021 to visit the office of the SPIO and he visited the office on the same day i.e. 23.07.2021 at 3.56 p.m., but refused to take the sought for information by saying that he had filed a Court case so he will not take any information and neither he will sign on any statement. The respondent further stated that then the sought for information consisting of 13 pages has been sent to the appellant through registered post at his given address.

The Commission has received a mail sent by the SPIO on 10.08.2021, diarized vide no.17641, which is a copy of letter no.43082/G dated 07.08.2021. I have gone through the said letter and the above mentioned facts have been submitted by the SPIO.

As the SPIO has sent the sought for information consisting of 13 pages to the appellant through registered post at his given address, so the SPIO has resolved the matter involved in the RTI application. Thus, the present appeal case is disposed of and closed.
