6. Copy of tour programmes / TA bills of school principal and payment vouchers of TA/DA bills. Copy of attendance register of school principal and leaves granted by DEO(SE) for year 2008 to 2020)

ORDER: Vide RTI application dated 13.08.2019 whereby the Appellant has sought the following information from DEO(SE), Amritsar:-

"Action Taken Report on my medical bill of Rs.15400/- for the right eye cataract operation along all original supporting documents sent to you by Speed post on 13.07.2015".

When no information was supplied by the PIO, he filed first appeal on 09.10.2019 to FFA. Again on getting no information even from the FAA he filed the appeal in the Commission on 05.08.2020.

2. The Appellant states that incorrect and incomplete information has been supplied by the Respondent.

3. The representative of the Respondents orally states that regarding misplacement of Medical Reimbursement Bill of Rs.15400/- action has been taken against erring Clerk, Shri Sukhbir Singh. The amount equal to the medical bill is being deducted from the salary of the erring official and the same will be paid to the appellant.

4. Therefore, the Respondent is directed to supply the correct and complete information to the appellant immediately by registered post under intimation to the Commission and in case of non-compliance of Commission's order within one month, **penalty will be imposed on the Respondent-PIO under the provisions of the RTI Act 2005.**

5. The appellant acknowledges the above and shows his willingness to close the case. However, he is at liberty to get the case reopened after one month in case the desired information is not supplied by the Respondent-PIO.

6. In view of the above, no more intervention of the Commission is called for in this case and hence, **the same is disposed and closed.** Copies of the order be sent to the parties.
