**ORDER**

1. The RTI application is dated 07.03.2020 vide which the appellant has sought information as enumerated in his RTI application. First appeal was filed with the First Appellate Authority (hereinafter FAA) on 15.06.2020 and second appeal was filed in the Commission on 11.09.2020 under Section 19 of the Right to Information Act, 2005 (hereinafter RTI Act).

2. Notice of hearing was issued to the parties for 14.10.2020 through CISCO webex.

3. Sh. Vishal Grover the appellant is appearing in the Commission office and states that he has not been provided complete information.

4. Respondent Sh. Kapil Bansal is appearing through CISCO Webex states that the information, as available, in the record has been provided to the appellant.

5. After hearing both the parties and examining the case file, it is observed that the appellant has demanded information on six points and the appellant Sh. Vishal Grover is satisfied on five points. Regarding point no. 6, he is not satisfied. The perusal of the file shows that the respondent has given in writing regarding point no. 6 that "*no more*
