ORDER

This order may be read with reference to the previous order dated 2.9.2020.

2. The complainant states that the respondents are not providing the information as has been sought by him but the authorities are exchanging the correspondence between them and supplied irrelevant 25 pages of information just to save the skin of the Block Development and Panchayats Officer. The complainant states that he has just sought the action taken on his complaint dated 1.8.2019 but he is being harassed.

3. It appears that the respondents are not providing the information as per the RTI application of the complainant and also he is being harassed. Video Conference Facility/cisco webex was introduced for convenience of general public and for the government officials. Viewing the absence of the respondents and dealing with the RTI application of the complainant seriously, Sh. Joginder Kumar, Deputy Director (L.D.) and Sh. Gagandeep Singh Virk, Divisional Deputy Director are, thus, issued a show cause notice to explain in a self-attested affidavit as to why a penalty @ Rs.250/- per day of delay subject to a maximum of Rs.25000/- till the complete information is furnished, be not imposed under Section 20(1) of RTI Act, 2005 on them for causing willful delay/denial of the information to the RTI applicant.

In addition to the written reply, the PIOs are also given an opportunity under Section 20(1) proviso thereto, for a personal hearing before the imposition of such penalty on the next date of hearing. They may take note that in case they do not file their written reply and do not avail themselves of the opportunity of personal hearing on the next date, it will be presumed that they have nothing to say and the Commission will proceed ex-parte.

ORDER

The RTI application is dated 9.7.2020 vide which the complainant has sought information as enumerated in his RTI application. Complaint was filed in the Commission on 14.8.2020 under Section 18 of the Right to Information Act, 2005 (hereinafter called RTI Act). Notice of hearing was issued to the parties for today.

2. The submissions have been received from the complainant, which are taken on record. Primarily, the complainant raised two points i.e. concerning the reference mentioned in a letter written to him by the Panchayat Secretary and secondly the Panchayat Secretary has not mentioned anything concerning the charge handed over/taken over in respect of the complaint from Sr. No. 1 to 12.

3. However, the Panchayat Secretary states that the Block Development and Panchayats Officer has transferred the RTI application under Section 6(3) of the RTI Act, 2005 so he has mentioned the letter No. 335 dated 27.7.2020 to clear the issue that no delay has been made in providing the information and the complete information has been provided to the complainant in this regard. A copy of the letter No. 335 dated 27.7.2020 sent by the respondent-Public Information Officer is taken on record and also a copy of the same is appended with the order for the complainant.

4. After going through the letter dated 27.7.2020, the plea taken by the Panchayat Secretary concerning the reference mentioned by the Panchayat Secretary as letter No. 335 dated 27.7.2020 in a letter bearing No. 6 dated 11.8.2020 issued to the complainant is accepted. But, the respondent-Public Information Officer is directed to file the reply/supply the information concerning handed over/taken over the charge regarding complaint No. 1 to 12 along with a copy of the proceeding book, if any before the next date of hearing.
