ORDER

When no information was provided to him by the PIO, then he filed First Appeal before the First Appellate Authority on 24.02.2020 and then Second Appeal before the Punjab State Information Commission on 10.08.2020. The case was registered and allocated to the Bench. Notice of hearing was issued to both the parties for today through **CISCO Webex Meetings Software**.

The appellant is absent today, whereas Shri Diwan Chand Sharma, SPIO-cum-DFSC, Sri Muktsar Sahib is present and he stated that the information, which was available in the office of the public authority has already been provided to the appellant and except that no other information is available in the office of the public authority.

The Commission has received an e-mail sent by the SPIO-cum-DFSC, Sri Muktsar Sahib, which is a copy of duly attested affidavit dated 14.10.2020 of Shri Diwan Chand Sharma, SPIO-cum-DFSC, Sri Muktsar Sahib.

I have gone through the contents of the affidavit and it is submitted by the SPIO that the sought for information has been sent to the appellant except the information related with point nos. 2 and 6 of the RTI application, which is not available in the office of the public authority, so the SPIO is unable to provide it to the appellant.

As the information which was available with the office of the respondent SPIO has already been provided to the appellant and the information related with point nos. 2 and 6 of the RTI application is not available in the office of the public authority, so the SPIO is unable to provide it to the appellant. Hence the present appeal case is **disposed of and closed**.
