ORDER:

1. The RTI application is dated **11.8.2020** vide which the appellant has sought information **regarding Senior Stenos / Personal Assistants etc.**, as enumerated in his RTI application. First Appeal was filed with the First Appellate Authority (FAA) on **29.9.2020** and Second Appeal was filed in the Commission on **16.3.2021** under Section 19 of the Right to Information Act, 2005. Notice was issued to the parties for first hearing in the Commission on **14.10.2021**.
2. Both parties are present absent without intimation. The respondent PIO has made a submission in response to this Commission's notice of hearing vide Letter No. 1495 Dated 26.7.2021, wherein he informs that the requested information has been supplied to the appellant vide Letter No. 8630 Dated 21.12.2020 and after certain deficiencies were pointed out by the appellant, additional information was supplied to him vide Letter No. 12953 Dated 16.2.2021. Copies of the above two letters have also been submitted to the Commission.
3. There has been no communication from the appellant since he filed this Second Appeal on 16.3.2021. This compels the Commission to conclude that the appellant is now satisfied with the information provided to him by the respondent PIO. There is no further cause for action and this Appeal Case is herewith, **CLOSED**.

ORDER:

1. The RTI application is dated **22.12.2020** vide which the appellant has sought information **regarding his own pension and service benefits etc.,** as enumerated in his RTI application. First Appeal was filed with the First Appellate Authority (FAA) on **18.2.2021** and Second Appeal was filed in the Commission on **9.4.2021** under Section 19 of the Right to Information Act, 2005. Notice was issued to the parties for first hearing in the Commission on **14.10.2020**.

2. Both parties are present via Video Conference Facility. The respondent PIO represented by Jaswinder Kaur, Superintendent, has stated in a detailed reply to this Commission's Notice for Hearing that information pertaining to points 1 to 4 of the RTI application has been supplied to the appellant. The appellant also present at this hearing confirms that he has received the information for points 1 to 4. The respondent PIO has also stated in her reply that the information requested from point no. 5 to 8 of the RTI application pertains to a third party and so was denied to the appellant. For this, she cites: *Appeal No. 10044 of 2010 titled in Central Public Information Officer Supreme Court of India Vs. Subhash Chandra Agarwal*. The respondent PIO's decision is upheld.

3. There is no further cause for action and this Appeal Case is herewith **CLOSED**.
