The complainant was apprised with the decision of the Hon’ble Supreme Court of India rendered on 12.12.2011 in Civil Appeal Nos.10787 – 10788 of 2011 (arising out of SLP © No.32768-32769/2010) has held that while entertaining a complaint under Section 18 of the RTI Act, 2005, the Commissioners have no jurisdiction to pass an order providing for an access to the information. Since the complainant has approached the Commission under the provisions of Section 18 of the RTI Act, 2005, no directions for providing further information can be given by the Commission.

She was also advised that an alternative and efficacious remedy of first appeal is available to the complainant under Section 19(1) of the RTI Act, 2005 which has not been availed in the instant case and the complainant requested that his case may be remanded back to the First Appellate Authority-cum-Secretary Ms Jasleen Kaur, PCS and his present case may be treated as first appeal. Accordingly, the Secretary-cum-First Appellate Authority, Punjab Public Service Commission, Patiala is directed to take appropriate decision after hearing both the parties and examining the record brought on file by passing
