The respondent has submitted a reply of the PIO stating that since the information relates to their Head Office, the RTI application was transferred to Sr.Environmental Engineer, Zonal Office-II on 23.01.2019 with a copy to the appellant, which further transferred it to Regional Office –III & IV on 28.01.2019 and 21.02.2019 respectively and a copy was sent to the Scientific Officer, PPCB, Head Office. The reply was also sent to the appellant. The Scientific Officer supplied the information to the appellant vide letter dated 02.04.2019.

Having gone through the information and the reply of the PIO, I find that the information has been supplied to the best possible extent and I see no malafide on the part of the PIO, hence no case of penal action is made out.

On being not satisfied with the reply, the appellant filed 2<sup>nd</sup> appeal in the Commission on 07.05.2019.

The appellant is absent and vide email through his counsel has informed that the PIO has not provided the information. The respondent has submitted a reply of the PIO which is taken on the file of the Commission.

Having gone through the file, I observe that there are two different replies of the PIO. In one reply which was sent on 25.02.2019, the PIO has mentioned that all large and medium industries which are covered under Hazardous wastes have submitted annual reports to the Board whereas in the 2<sup>nd</sup> reply which was sent on 25.03.2019, the PIO has mentioned that no separate record is being maintained and they are unable to provide the information. I find the reply to be wishy-washy and it appears to be an attempt to stonewall the information. The PIO is directed to clarify and if such information exists on record, to provide the information.

The case is adjourned for further hearing on **21.01.2020 at 11.00 AM.**

The respondent present pleaded that the information has been provided to the appellant. The appellant vide letter received in the Commission on 13.11.2019 has withdrawn his appeal case.

No further course of action is required. The case is **disposed off and closed.**
