3. Shri Rajneesh Kumar, Executive Officer/PIO, Municipal Council, Sri Muktsar Sahib comes present in person before the Bench and states that he has recently joined and his predecessor had given reply to the appellant vide letter dated 22.09.2022. He further states that the appellant was called to his office on 07.1.2022 and the point-wise information has been supplied to him and clarified Reply given by the PIO is also discussed during the hearing.
4. On the asking of this Bench, the appellant expresses dis-satisfaction over the reply of the PIO and states that reply was given to him after one year of his RTI application.
5. Post deliberations, the PIO apprises the Bench that the information as available in the official records has been supplied to him.
6. The Bench now directs the PIO to file an affidavit on e-stamp paper, within 21 (Twenty One) days, duly signed by the PIO and attested by the Notary Public to the effect that the information as available in the official records in **AC No.5735/2021** has been supplied to the appellant. It be further stated that nothing has been concealed therein and the statement made is true and correct. Original affidavit be sent to the appellant and copy of the same be sent to the Commission for record.
6. With the aforesaid directions, **the instant appeal case is disposed off and closed.** Copies of the order be sent to the concerned parties.
