Order:

1. This is with reference to earlier order dated 09.12.2021 vide which Ms. Sapna on behalf of the appellant requested for an adjournment. Respondent PIO, Ms. Kulwinder Kaur was directed to comply with the previous orders of the Commission dated 30.11.2021 regarding submission of affidavit before the next date of hearing positively. 3. On this, respondent PIO, Ms. Kulwinder Kaur states that affidavit dated 09.12.2021 has already been supplied to the appellant. Nothing is left to be supplied by the respondent PIO.
4. After hearing both the parties and examining the case file, matter is adjourned for further hearing on **21.12.2021 at 11:00 AM through CISCO WEBEX application** with the directions to the respondent PIO to go through the RTI application once again and clear the facts regarding point no. 1, 3 and 4 positively.
5. Appellant is also advised to represent this case in person on the next date of hearing positively.
