In case the SPIO would not come present and would not file reply to the show cause notice then it will be assumed that he do not want to say anything in his defense and the show cause notice will be decided without hearing him and a penalty of Rs. 25,000/- will be imposed upon him.

Both the parties should personally come present on the next date of hearing i.e. **21.12.2021** at **10:30 A.M**.
