- b) Provide copy of application no. 1149 (DSP Spl) dated 17.11.2020 in O/o SSP (Rural), Jalandhar filed by applicant.

Shri Ravi Kumar, IPS, SP (HQ), Jalandhar stated that regarding point no. 'a' of the RTI application relating to complaint no. 130 BH/R dated 11.03.2020, after the inquiry FIR No. 47 dated 01.03.2021 U/s 406/498-A IPC was registered at Police Station, Phillaur, Distt Jalandhar, (Rural), but as the investigation is still under process so the information relating to point no. 'a' is concerned, it is the investigation regarding FIR No. 47 dated 01.03.2021 U/s 406/498-A IPC registered at Police Station, Phillaur, Distt Jalandhar, (Rural) which is still under investigation and the information cannot be provided as it is exempted U/s 8(1)(h) of the RTI Act, 2005.

The present appeal case is **disposed of and closed** with the observation that whenever the investigation will be completed and the challan will be put up before the appropriate Court, then the attested copies of related information asked by the appellant be sent to him through registered post within 10 days and compliance report be sent back to the Commission.
