Order

3. The appellant is absent today without any intimation.
4. The representatives of the respondents states that the information has already been supplied to the appellant and the same has also been sent to the Commission through email on 11.2.2022, which is taken on the record. They further submit that the appellant has not pointed out any deficiency in the information so supplied to him.
5. The appellant remained absent during the last two hearings and also he is absent today without intimation. The Commission's office also tried to contact him on telephone but he could not be contacted. Again the office sent a message through SMS directing him to appear in the hearing before the Commission through video conference facility available in the office of the Deputy Commissioner Jalandhar. Even then neither the appellant sent any reply nor pointed out any deficiency in the information. The information so received from the respondent is also being sent to the appellant.
