ORDER

This order may be read with reference to the previous order dated 7.2.2022

2. The brief of the case is that the appellant is an employee of the respondent authority and has sought the information related to other employee Sh. Nachattar Singh due to promotion and pay parity. The appellant has sought the following information:-

4. Sh. Nachattar Singh submits that his information i.e. copy of service book may not be supplied to Sh. Amarjit Singh as the case is pending in the Hon'ble Punjab and Haryana High Court, Chandigarh. However, the appellant submits that the directions may be issued to the respondent-Public Information Officer to supply the information.

5. After detailed deliberations with both the parties and going through the case file, it has transpired that there is no stay order given by any Hon'ble Court. Therefore, the directions are issued to the respondent to supply the information i.e. copy of pay fixation orders of Sh. Nachattar Singh from 1.1.1997 to 31.7.2021, and not the copy of the service book, to the appellant in the public interest. The representative of the respondents assures that the complete information i.e. pay fixation orders of Sh. Nachattar Singh, Lecturer will be supplied to the appellant within two weeks. According to the assurance given by the respondent, the Commission is of the view that no further action is required to be taken in this case. Hence the case is disposed of and closed. However, the liberty is granted to the appellant to approach the Commission within four weeks in case he does not receive the pay fixation orders of Sh. Nachattar Singh, Lecturer as per the assurance given by the respondent.

ORDER
